### 7. Swimming Pool.

Mr. Hassler updated the council on the pool operations for 2005. The pool lost over \$16,000 in 2005 which was less than previous years. There was a discussion on the repairs necessary to be able to open the pool in the summer of 2006. The estimate for repairs was given by staff at \$2,500. Additional repairs and improvements to the pool were also offered. The recommendation of staff was to only make the necessary repairs to the pool unless a Jones Foundation grant could be secured to pay for the other proposed improvements.
