

**Burlingame City Council Minutes**  
**Regular Meeting**  
**April 3, 2006**

**1. Call to Order by Mayor.**

The Mayor called the meeting to order at 7:00pm.

**2. Roll Call.**

**3. Citizen Comments.**

Darin Lee, John Dorr, and Paula Lawless were present to represent the Recreation Commission. They asked the council the following:

1. if they could spend Recreation Commission money to add lime and laser level the infields prior to the 2006 ball season;
2. if the City could install a new sink in the concession stand to comply with state regulations to allow the Recreation Commission to serve hot foods during the ball season;
3. if the water could be turned on in the concession stand for the bathrooms and to allow for the cleaning of the concession stand prior to an inspection by the State.

The Council approved the request for the infield with the understanding that the City was going to submit a grant to the Jones Foundation to make improvements to the fields in the fall/winter of 2006. The sink installation has already been scheduled by City crews, and the restrooms would be open in two weeks to hopefully prevent the pipes from freezing.

The Council discussed the budgeted capital projects for 2006 at the work session on March 27<sup>th</sup>. Staff made several recommended changes from what was originally budgeted.

Motion to authorize staff to proceed with the following capital projects:

1. Use \$18,000 budgeted for chip seal, curb and gutter projects, sidewalks, and skate park for chip sealing streets;
2. Use \$15,000 budgeted for US56 Hwy power line upgrade to:
  - a. Rebuild Elvis Finley service;
  - b. Rebuild Bill Gifford service;
  - c. Rebuild feeder line and service line to Alton Mills;
  - d. Rebuild primary line along 181<sup>st</sup> Street.
3. Extend water line along Fast Drive to service Ray Hovestadt's new house;
4. Use money budgeted for gas lines to new subdivisions to replace line in Osage City for \$13,000;
5. Use money budgeted for manhole rehabilitation to start pilot project using City crews;

Julie Sanders – Ms. Sanders asked how the water project was proceeding and asked if the old car wash on US 56 Hwy was inside the City limits. Mr. Hassler responded that the water project was proceeding nicely with just a few minor issues. There was a progress meeting scheduled for Friday with the contractor and engineer to discuss the project. Mr. Hassler also informed the council that the car wash was located outside the City limits and the County had indicated they could not do anything about the situation.

Chris Dubois – Mr. Dubois asked if staff had had time to compile a list of major electrical users. Mr. Hassler informed the council that staff had not done this yet. Mr. Dubois also asked about the truck and mess located in Jones Park. Staff was not aware of it, but would check on it.

Bill Kraus – Mr. Kraus stated it had been brought to his attention by Mr. Hassler that Mr. Swander had told at least one City staff member that City equipment could be used personally as long as it did not interfere with City business. Mr. Hassler had informed the staff member that this was not allowed. Mr. Kraus stated he believed that Mr. Swander was overstepping his bounds as a council member and that this was not the first occurrence. It was determined that this issue would be discussed at the future meeting when all council members were present.
