The Burlingame Burn Site has been leveled and fence work will continue.

Chief Dudley - Nuisance letters will be going out this week. Reminder that the proper procedure for reporting a concern is to complete a concern form at City Hall and the concern will be addressed as deemed necessary.

Councilmember Burns – Shared an example of a police report from another city and stated that she will expect a similar report from Chief Dudley at the June 2<sup>nd</sup>, 2014 meeting.

Councilmember Strohm – Stated that the police officers are welcome to park at the edge of her driveway, but would appreciate if they parked to the side and not in the middle. Strohm voiced concerns regarding the condition of the shelter houses at the park.

Councilmember Mullinix – Discussed the Recreation Commissions ideas for a trailer and/or shed and a portable restroom to be placed by the concession stands.

Mayor Dorr - Received call from Stephanie Watson of the Osage County Rural Development office that the tax credits were unable to be sold and will apply again next year.
